Regulated Cannabis Industry Engages In Steps Toward Pesticide Enforcement

WACA calls for specific pesticide regulations to protect public safety, establish action thresholds for product recall and public notice

WASHINGTON – The Washington CannaBusiness Association (WACA) today thanked the Washington State Liquor and Cannabis Board (LCB) for forwarding emergency rules regarding pesticide enforcement in the regulated cannabis marketplace. WACA earlier this month <u>submitted proposals</u> to strengthen pesticide enforcement to the LCB as part of the rule-making process. Specifically, WACA shared five proposed solutions:

- Continued robust random testing by LCB.
- Create uniform regulations for labs testing product. False positives and negatives should concern everyone regulators, businesses, consumers and patients.
- Review how the United States Department of Agriculture manages pesticides in administering the National Organic Program. For Certified Organic products some pesticides are permitted and even for prohibited pesticides, allowances are made if detected at low enough limits due to the challenges of crosscontamination and the persistence of some substances unintentionally introduced.
- Action Levels for prohibited pesticides rather than "zero" tolerances. This creates
 a science-based system for protecting consumer safety and potentially minimizes
 errors that could be introduced by labs.
- Support a "disclosure upon request" model so that any consumer, patient or interested party can find out which pesticides, if any, have been applied to the product in question.

"Today is a step forward in addressing pesticide concerns shared by the general public, regulators and the regulated cannabis industry in Washington," said WACA Executive Director Vicki Christophersen. "As an industry, we ask that regulators consider clear and specific guidelines to support compliance with critical pesticide regulations crafted to support public safety: pesticide thresholds that would trigger a recall, public notice requirements in the event of a recall, consideration of successful models in analogous systems, robust testing of products by regulators and strict certification requirements for labs. We look forward to continuing to engage with lawmakers and regulators as they

finalize regulations in this critical work to protect public safety in our quality-controlled and regulated cannabis marketplace."
